No. 25960—SE/1-34/99-SE.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa is pleased to amend the Orissa Secretariat Private Secretaries Service Rules, 1997, namely:—

- (1) These rules may be called the Orissa Secretariat Private Secretaries Service (Amendment) Rules, 1999.
- (2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Secretariat Private Secretaries Service Rules, 1997, for the words "Private Secretary (Grade B)", "Private Secretary (Grade A)" and "Senior Private Secretary", wherever they occur the words "Private Secretary", "Senior Private Secretary" and "Principal Private Secretary" shall respectively be substituted.
