Sub: Enhancement of the rate of duty allowance/training allowance of Civil Defence Volunteers.

Sir,

In pursuance of the decision of the Government of India communicated in Ministry of Home Affairs, D.G.C.D. letter No. II-29012/41/96-DGCD(CD), dated 28-10-96, I am directed to convey the sanction of Governor to the enhancement of the duty allowance and training allowance of Civil Defence Volunteers as detailed below:

<u>Type of Allowance</u>	<u>Existing Scale/Rate</u>	<u>Revised rate/scale</u>
(A) Duty Allowance	Rs. 22/- per head per day	Rs. 31/- per head per day.
(B) Training/Parade Allowance	(i) Rs. 10/- per head per parade/training of $2\frac{1}{2}$ hours duration but not less than $1\frac{1}{2}$ hours	(i) Rs. 14/- per head per parade/training of $2\frac{1}{2}$ hours duration but not less than $1\frac{1}{2}$ hours.
	(ii) Rs. 20/- per head per day for more than one parade/training hours exceeding $2\frac{1}{2}$ hours duration.	(ii) Rs. 28/- per head per day for more than one parade/training hours exceeding $2\frac{1}{2}$ hours duration.

2. This is effective from 1-4-1996.

3. The rates of training allowance/duty call-up allowance to Civil Defence Volunteers fixed in this Department G.O. 1085/CD, dated 28-5-87 and G.O. No. 980/CD, dated 22-5-90 are hereby superseded.
