**Sub: Creation of posts for establishment of a new Traffic Police Station at Chandrasekharpur under Bhubaneswar UPD.**

I am directed to convey the sanction of the Governor for establishment of a new Traffic Police Station at Chandrasekharpur under Bhubaneswar UPD covering an area of eight Police Stations i.e. Nandankanan Police Station, Chandrasekharpur Police Station, Info-city Police Station, Jatani Police Station, Tamando Police Station, Khandagiri Police Station, Chandaka Police Station and Nayapalli Police Station, with creation of total 171 posts of Traffic Police Personnel of different categories as indicated below:

The base level posts meant for direct recruitment shall be filled up on Contractual basis initially following the relevant recruitment rules and provision of ORV Act and as per the stipulations contained in the G.A. Department Notification No.32010/Gen dated 12.11.2013 and Notification No.1147/Gen dated 17.01.2014 read with Notification No.4587/Gen dated 15.02.2014. Their service conditions and emoluments shall be governed by the aforesaid Notifications of the G.A. Department. The promotional posts may be filled up following the relevant rules and provisions of ORV Act.

The charges on the account are debatable to the grant under head Demand No.2055-Police Non Plan-001- Direction and Administration-1712-Introduction of Commissionerate system in the twin cities of Bhubaneswar-Cuttack in the Budget Estimate of 2017-2018.


