Sub: Proposal for creation of posts of Legal Advisor in different offices of Odisha Police.

Sir,

In inviting a reference to the Letter No.180/Policy dated 03.01.2017 of State Police Headquarters, Odisha, Cuttack on the subject noted above, I am directed to convey the approval of Government for engagement of one Retd. District Judge/Additional District Judge/Public Prosecutors/Additional Public Prosecutors on re-employment basis as Legal Advisor for CID, CB, Odisha, Cuttack only.

The consolidated remuneration may be fixed in consultation with CS-III of the Finance Department.


This has been concurred in Finance Department File No.FIN-GS1-CADRE-0015-2017 and Finance Department have advised and stipulated in this regard as follows:-

"The 32 Police Districts for which engagement of retired District Judges/Addl. District Judges/Public Prosecutors/Addl. Public Prosecutors on re-employment basis as Legal Advisors include Cuttack Police District and Khurda Police district where UPD Cuttack and UPD Bhubaneswar are situated. Hence, the Legal Advisors of Police District, Cuttack and Khurda can be assigned the work of UPD, Cuttack and Bhubaneswar respectively.

The performance of Legal Officers at least once in a quarter should be reviewed. Continuance of system of Legal Advisor after first year would be considered only after assessment of the impact of the new system on improving the quality of investigation."

In view of above, necessary steps may kindly be taken for engagement of Legal Advisor in CID, CB, Cuttack.
