In case the immigration function are taken over by Bureau of Immigration (BoI) in future, the posts sanctioned for Immigration Check Post at Biju Pattnaik International Airport, Bhubaneswar would become redundant and in that eventuality the post sanctioned for Immigration Check Post at Biju Pattnaik International Airport, Bhubaneswar should be brought over to sanctioned strength of Commissionerate of Police, Bhubaneswar and Cuttack.

3. The newly created posts shall be filled up following the relevant recruitment rules and provisions of ORV Act. The base level posts up to the Grade Pay of Rs.4200/- shall be filled up on contractual basis initially as per the stipulations contained in G.A. Department Notification No.32010/Gen, dated 12.11.2013 and No.1147/Gen, dated


