I am directed to convey the sanction of the Governor for creation of the following 200 (two hundred) different categories of additional posts of traffic police personnel in 32 Police Districts and Police Commissionerate, Bhubaneswar-Cuttack including Biju Pattanaik International Airport, Bhubaneswar in the scale of pay noted against each with usual D.A. and other allowances as admissible from time to time with effect from the date the posts are actually filled up for effective enforcement of traffic discipline.

- 2. The above newly created 200 additional posts of traffic personnel shall be distributed between different Police Districts, Commissionerate Police, Bhubaneswar-Cuttack and Biju Pattanaik International Airport considering their requirement
- 3. The base level posts meant for direct recruitment may be filled up on contractual basis initially following the new recruitment rules and provisions of ORV Act notified vide G.A. Department Notification No.32010/Gen dated 12.11.2013 and Notification No. 1147/Gen dated 17.01.2014 read with Notification No.4587/Gen dated 15.02.2014. Their service conditions and emoluments shall be governed by the aforesaid notifications of G.A. Department. The promotional posts may be filled up following the relevant rules and provisions of ORV Act.
