Sub:- Re-fixation of territorial jurisdiction of S.D.P.Os. of Titilagarh, Bolangir Sadar, Patnagarh and Kantabanji Police Sub-Division in Bolangir District.

Pursuant to up-gradation of the post of Circle Inspectors of Bolangir Sadar and Patnagarh to that of Deputy Superintendent of Police and creation of a new Police Sub-Division at Kantabanji, Government have been pleased to re-define the jurisdiction of Sub-Divisional Police Officers of Bolangir District into Titilagarh, Bolangir Sadar, Patnagarh and Kantabanji Police Sub-Divisions as per Rule 1 A (2) of Odisha Police Manual, Volume – I. The Sub-Divisional Police Officers of Bolangir Sadar, Titilagarh, Patnagarh and Kantabanji Police Sub-Divisions shall supervise the work of the Police Stations as indicated in the table below.

All the Sub-Divisional Police Officers shall exercise concurrent jurisdiction on Special Police Station (Energy), Bolangir in their respective areas.


