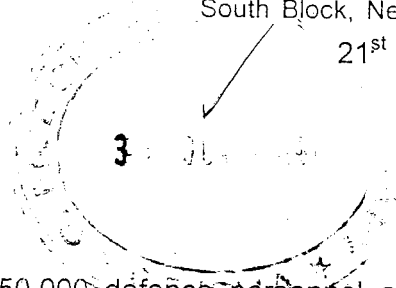

Dear Chief Secretary,

As you are aware, around 50,000 defence personnel are discharged from service every year to maintain the youthful profile of the Armed Forces. Substantial number of these Ex-Servicemen require re-employment in order to fulfil their family and social responsibilities.

2. The Government is committed to provide meaningful resettlement opportunities to Ex-Servicemen. Accordingly, under the provisions of Ex-Servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979, the Central Government provides for reservation ranging from 10% to 24.5% in jobs in Central Ministries / Departments / PSUs / Banks etc. Ex-Servicemen are also given reservation up to Assistant Commandant rank in the Central para Military Forces.

3. The State Governments have several welfare schemes for Ex-Servicemen and their families and also provide reservation in jobs for them. There is however, no uniformity in the percentage of reservation across the States.

4. I shall be grateful if you could kindly arrange to have information regarding the percentage of reservation available for Ex-Servicemen in Government jobs in your State, along with details of employment provided to them during the last three years, sent to this Department. Separate data may also kindly be provided in respect of the reservation quota, if any, and number of Ex-Servicemen recruited in the State Police Forces during the last three years.
