No-HOME-SPS—PMTN-00.10-2014 18110 /SPS, As per recommendation of the DPC held on 30.12.2013, Sri Nishakar Prusty, Inspector of Police, is promoted retrospectively on adhoc basis to the rank of DSP, in the scale of pay of Rs. 9,300-34, 800/- with Grade Pay of Rs. 5, 400/- P.M. in P.B.-2 notionally with effect from the date, his immediate junior Sri Ramesh Ch.
