Bhubaneswar, dated, the, 6th April, 2007.

No. PDA-II-175/06(pt-II)-I. 18415 / D&A , In pursuance of the direction of the Hon'ble Supreme Court dated 22.9.2006 & order dated 11.01.2007 in Writ Petition (C) No.310/96 Prakash Singh and Others -Vrs- Union of India and Others, the functioning of investigation and law and order duties in the Police Stations of Cuttack and Bhubaneswar cities are separated with effect from the date of issue of this Notification. subject to the following :


1. The investigation wing of the Police Station shall inter alia take up enquiries, investigation of cases, measures to prevent commission of crime, maintenance of Registers/documents pertaining to crime etc.
2. The law and order wing of the Police Station shall be responsible inter alia for collection of intelligence, police arrangements for handling law and order situations and effective 'bandobast' to avert any breach of public peace.
3. There shall be perfect coordination between the two wings, which shall function under the I.I.C./O.I.C. of the concerned Police Station.
4. The investigation and law and order wings of the Police Station shall be headed by two Senior officers not below the rank of Sub-Inspectors of Police, to be appointed by the Superintendent of Police of the District.
5. Subordinate ranks in the Police Station namely Head Constables and Constables shall be divided and attached to both the wings, leaving a small group to assist the I.I.C. / O.I.C.in his day to day functioning.
6. The actual distribution of the man power shall be done on a realistic basis, keeping in view the work load of the Police Station in investigation and law and order responsibilities, by the District Superintendent of Police, subject to approval of the Director General of Police.

Ordered that this shall be published in the next issue of Orissa Gazette.


