In pursuance of the direction of the Hon'ble Supreme Court dated 22.09.2006 and order dated 11.01.2007 in Writ Petition (C) No.310/96 Prakash Singh and others -Vrs.- Union of India and others, the State Government do hereby constitute a Police Complaints Authority at the State Level to look into complaints against Police Officers of the rank of Additional Superintendent of Police and above.


The State Level Complaints Authority shall be vested in the Hon'ble Lokpal who shall deal with the complaints under the Orissa Lokpal and Lokayuktas Act, 1995

2. The Hon'ble Lokpal may be assisted by such other persons as may be decided by the Government in consultation with the Hon'ble Lokpal.
3. The persons so appointed under paragraph 2 above shall work whole time for the Authority and shall be suitably remunerated for the service rendered by them.
4. The recommendations of the Complaints Authority shall be dealt with in accordance with the procedure laid down under the Orissa Lokpal and Lokayuktas Act, 1995

The Notification shall come to force from the date of its issue.
