Sub: Creation of posts of Judicial Officers and Court Staff for newly established 24 POCSO Courts .

Sir,

In continuation of Home Department Letter No.8880 Dated 24th February, 2020 on the above subject, I am directed to say that after careful consideration of proposal, Government have been pleased for sanction of creation of posts for each of the 24 POCSO Courts as detailed below:

- I) One post of Junior clerk each for 24 courts in addition to 2 posts of Junior clerk each approved earlier.
- II) One additional post of Peon for each POCSO Court in addition to one post of Peon sanctioned earlier for each POCSO court.
- III) The newly created posts of Junior clerk and peon as approved above shall be filled up following the relevant recruitment rule and provision of ORV Act. The base-level Group-C and D posts may be filled up initially on contractual basis in terms of stipulations contained in erstwhile G.A Department Notification No.32010/Gen dated 12.11.2013. Their remuneration shall be governed by G.A. Department Notification No. 19574 / Gen dated 12.09.2017.
- IV) There will be no need for the creation of Post of Driver and the vehicle will be hired.
