There shall be a "Range Police Establishment Board" in each Police Range comprising of the following officers to decide all inter-district transfers of executive police personnel up to the rank of Inspector of Police and equivalent rank.

The District Police Establishment Board will decide the distribution of duties amongst the headquarter Deputy Superintendents of Police and Additional Superintendents of Police.


The Director General & Inspector General of police may interfere with the decision of the Range and District Police Establishment Boards in exceptional cases for reasons to be recorded in writing.
