**Subject: Recruitment of Assistant Jailor in Orissa Jails.**

The State Government do hereby make the following Amendments to Resolution No.45358, dated 27.10.2006:-

Part-B

Para-9 is substituted as

9- There shall be a preliminary examination with objective type questions of 50(fifty) marks to be answered in 30(thirty) minutes. Candidates securing 30(thirty)marks or more shall be eligible for the Written Examination.

Written Examination:- The written examination shall consist of three papers in two sittings as stated below:

<u>Subject</u>	<u>Maximum Marks</u>	<u>Time.</u>
General English	50	One hour.
Oriya Language	50	One hour.
General Knowledge & Arithmetic(H.S.C. Standard)	200	Two hours and Thirty minutes.

The Following shall be inserted under Para-15.

**15A: The Physical Efficiency and Psychological Tests-Qualifying.**

(1) For Men of all categories: The Physical Efficiency Tests shall comprise of the following events.

- (i) Running 1.6 kilometer in 8 minutes.
- (ii)Cycling 1.6 kilometer in 5 minutes.
- (iii)Running over low hurdles of 76 centimeters height, 100 meters with 10 flights, in 25 seconds.
- (iv)Broad jump of 3.65 meters in length in three attempts
- (v)Cross-country- 5 Kms.

If covered within 40 minute - Qualified.

Beyond 40 minutes- Disqualified.

(2) For Women of all categories:

- (i) Running 1.6 kilometer in 10 minutes.
- ii) Cycling 1.6 kilometer in 7 minutes.
- (iii) Running 80 meters of low hurdles of 60 centimeters height and with with 10 flights, in 30 seconds.
- (iv) Broad jump of 2.7 meters in length in three attempts
- (v) Cross-country- 4 Kms.

If covered within 40 minute - Qualified.  
 Beyond 40 minutes- Disqualified.

(3) Psychological test will be designed by Commission in consultation with I.G. of Prisons and others as deemed fit by them. It shall be designed to test the suitability of the candidates for the job. Those who fail in the test shall be disqualified. No marks shall be awarded to those, who pass the test.
