

(HOME-CC-RULE-0030-2016)

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha hereby makes the following rules further to amend the Odisha Secretariat Data Entry Operators (Method of Recruitment and Conditions of Service) Rules, 2008, namely:-

1. Short title and commencement: (1) These rules may be called the Odisha Secretariat Data Entry Operators (Method of Recruitment and Conditions of Service) Amendment Rules, 2016.
(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha Secretariat Data Entry Operators (Method of Recruitment and Conditions of Service) Rules, 2008 in Appendix to the said rules as referred to in sub rule (2) of rule 8 the test prescribed at serial No.3 under heading "Distribution of weightage for marking of the recruitment examination papers for Data Entry Operators" shall be omitted.
