In exercise of the Powers conferred by Section 3(1) of the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act, 1988 (No. 46 of 1988), the State Government do hereby declare and empower the Principal Secretary to Government, Home Department, Odisha as the detaining authority for the purpose of preventive detention of any person (including a foreigner) from engaging in Illicit traffic in Narcotic Drugs and Psychotropic Substances under Section-3 of the said Act.

This supersedes the Excise Department Notification No.IEX-12/2002-3781/Ex dt.14.06.2002.




