Rapid urbanization has caused manifold increase of population of Bhubaneswar City which result in considerable growth of vehicular traffic. Due to expansion of city limits, new traffic intersections have come up and resources available are too inadequate to manage hurdles of day to day traffic. Lack of parking places, lack of electronic traffic signaling system and engineering defects etc are some major issues faced by the traffic police. 7. Project Director, NHAI, Bhubaneswar- Member




