No.46504-CHR-CRTN2-0001/2012/C&HR.— In pursuance of Section 14 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 (33 of 1989) and in supersession of all notifications issued in this regard, the State Government, with the concurrence of the Chief Justice of the High Court of Orissa, do hereby specify the Courts of District and Sessions Judges and Additional District and Sessions Judges as mentioned in column (2) of the Schedule below, to be the Special Courts to try the offences under the said Act within the local limits as specified against each in column (3) thereof.
