

Terms and reference:

1. The State Level Coastal Security Committee will monitor the relevant aspects of the Coastal Security as are being coordinated/taking care of at Coastal State Level or as assigned by MHA;
2. State level Coastal Security Committee may also review functioning & monitoring of Coastal District level Committee;
3. The Chairman of the Committee may incorporate appropriate members as a Special invitees for specific issues;
4. The State Level Coastal Security Committee will meet every six months.
