In exercise of the powers conferred by clause(s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of all previous notifications so far as it relates to establishment of Ranpur Police Station in Nayagarh district, the State Government do hereby declare Chandapur Outpost in Nayagarh district to be a Police Station called **Chandapur Police Station** which shall include the villages as specified in column (3) in the schedule below and direct that the same shall come into force from the date of publication of this notification in the Odisha Gazette.


