Pursuant to creation of a new Police Sub-Division at Purusottampur in Ganjam district, Government have been pleased to partially modify Home Department Order No.46083 dt.16.10.2009 so far as jurisdiction of the Sub-Divisional Police Officer, Chhatrapur is concerned and re-define the jurisdiction of Sub-Divisional Police Officers of Chhatrapur and Purusottampur Police Sub-Divisions as per Rule 1 A (2) of Odisha Police Manual, Volume – I. The Sub-Divisional Police Officers of Chhatrapur and Purusottampur Police Sub-Divisions shall supervise the work of the Police Stations as indicated in the table below.


All the Sub-Divisional Police Officers shall exercise concurrent jurisdiction on Special Police Station (Energy), Ganjam in their respective areas.


