RESOLUTION

No. 537 /D&A, Bhubaneswar, Dated 05.01.2016

Sub: Revision of Risk Allowance to the personnel of the Special Operation Group.


In continuation of this Deptt. letter No.33019/195/2003 dt.21.8.2004 and Resolution No.44800 dt.30.9.2008, Govt. have been pleased to decide that the S.O.G. personnel will be entitled to either Risk Allowance of 60% or Special Allowance of 20% as per the following criteria.

1. Risk Allowance of 60% of the Basic Pay shall be extended only to the personnel of S.O.G. who are performing active operational duties in Naxal affected areas.
2. The Special Allowance of 20% of the Basic Pay shall be extended to the personnel of S.O.G. who are not in active operational duties and are deployed for training, administrative and other related matters at S.O.G. Headquarters, Chandaka, Bhubaneswar and as members of S.T.U. (Special Tactical Unit) stationed at Bhubaneswar.
3. A committee consisting of I.G. of Police (Operations)/ D.I.G. of Police (Operations) as Chairman, Commandant, S.O.G. and S.P., S.I.W. as Members will decide admissibility of Risk Allowance/Special Allowance to the different personnel of S.O.G. depending on their nature of duties subject to the approval of the Director, Intelligence.

This will be effective from the date of issue of this Resolution.


