
NOTIFICATION

Dated, Bhubaneswar the 27.08.2016

HOME-DA1-PWR-0068-2014-No. 30/30 /D&A. In partial modification of the notification of the Government of Odisha in the Home Department No. 1833/D&A dated the 15th January, 2009 published in the extraordinary issue of the Odisha Gazette No.64 dated the 16th January , 2009 and in exercise of the power conferred by section 115 of the Odisha Urban Police Act, 2003 (Odisha Act 8 of 2007), the State Government do hereby specify that the Assistant Sub-Inspectors of Police and Sub-Inspectors of Police posted or attached to the Traffic Police Stations within the Police Commissionerate area or authorized by the commissioner of Police, Bhubaneswar-Cuttack, Bhubaneswar, on duty in addition to the Police Officers specified in the said notification, shall be competent to compound offences punishable under section 96 of the said Act to the extent of the amount as specified in column (3) thereof if paid by the offenders in the designated places mentioned in column (4) of the said notification, within the territorial jurisdiction of the Police Commissionerate, twin cities of Bhubaneswar and Cuttack.


This notification shall come into force from the date of its publications in the extra ordinary issue of the Odisha Gazette.




