HOME-DA1-RULE-0002-2018

In exercise of the power conferred by section-2 of the Police Act, 1861 (Act No.5 of 1861), the State Government do here by make the following rules to amend the Odisha Police Service (Conditions of Service and Method of Recruitment of Sub-Inspectors, Handwriting Bureau, CID-CB) Rules, 2011, namely: -

Short title and Commencement – 1. (1) These rules may be called the Odisha Police Service (Conditions of Service and Method of Recruitment of Sub-Inspectors, Handwriting Bureau, CID-CB) (Amendment) Rules, 2018

(2) They shall come in to force on the date of their publication in the Odisha Gazette.

2. In the Odisha Police Service (Conditions of Service and Method of Recruitment of Sub-Inspectors, Handwriting Bureau, CID-CB) Rules, 2011, (here in after referred to as the said rules), for rule 11, 12 and 13, the following rules shall be substituted, namely: -

“11. The Physical Efficiency Test – Qualifying:

(1) **For Men of all categories:** The Physical efficiency Tests shall comprise of the following events: -

- a) Running one mile in 8 minutes.
- b) Cycling one mile in 5 minutes.
- c) Running over low hurdle of 2 feet 6 inches height, 100 meters with 10 flights in 25 seconds.
- d) Broad Jump of 12 feet in length in three attempts.
- e) Cross-country of 5 Kms if covered within 40 minutes.

(2) **For Women of all categories:**

- a) Running one mile in 10 minutes.
- b) Cycling one mile in 7 minutes.
- c) Running 80 meters of low hurdles of 2 feet height and with 10 flights, in 30 seconds.
- d) Broad jump of 9 feet in length in three attempts.
- e) Cross-country of 4 Kms if covered within 40 minutes.

12. **Viva Voice-cum-Psychological Test: -**

- I. The candidate qualifying in the physical standards and physical efficiency test only shall be eligible for the Viva Voice-cum-Psychological Test.
- II. The Test shall carry 30 (thirty) marks (with no minimum qualifying marks).

13. **Marks for NCC Certificates:**

- (1) These marks shall be awarded after due verification of original certificates as below: -

For NCC Certificates (Marks allotted: 10)

(i)	N.C.C. 'A' Certificate	5
(ii)	N.C.C. 'B' Certificate	7
(iii)	N.C.C. 'C' Certificate	10

3. In the said rules in rule-14, for sub-rule (5), the following shall be substituted, namely: -

“(5) Marks obtained in written test, Viva Voice-cum-Physiological Test and NCC Certificate shall be added for preparing the merit list. The Commission may prepare a common merit list and category wise merit list of the candidates basing on the aggregate marks obtained by each.”






