
The post of S.P., C.M. Security shall be held by a Commandant (OAPS) or a D.I.G. level Officer depending on suitability and availability of Officers. Similarly the posts of Inspector and Sub-Inspectors may be held by equivalent rank officers depending on suitability and availability of officers.

The base level posts meant for direct recruitment shall be filled up on contractual basis initially following the relevant recruitment rules and provision of ORV Act as well as the stipulations contained in the erstwhile G.A Department Notification No. 32010/ Gen. dated 12.11.2013 read with Notification No. 1147/Gen. dated 17-01-2014. Their service conditions and emoluments will be governed by the said notification.

The charge is debitable to Demand No.1-2055-Police-Non-Plan-101-Criminal Investigation & Vigilance voted in the Budget Estimate for the year 2018-19.
