O R D E R

No. 27688 / IPS Bhubaneswar dated the 20th August, 2020.
HOME-IPS-SVCOND-0001-2020

Whereas Ministry of Home Affairs, Government of India in exercise of the powers conferred under Sub-Rule (2) of Rule 5 of Indian Police Service (Cadre) Rules-I 954, and with the concurrence of the Government of West Bengal and the Government of Odisha transferred Ms. Loganayagi Divya V. IPS (WB:2013) vide their notification dated 12.09.2017 from West Bengal to the IPS Cadre of Odisha on the grounds of her marriage with Shri Rahul P.R, IPS (OD:2013).

And Whereas Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi in OA No.1919 of 2019 filed by Ms. Loganayagi Divya V passed an order dated 28.02.2020 directing the Government of West Bengal to relieve Ms. Loganayagi Divya V. within four weeks from the date of receipt of the court order.

And Whereas Hon'ble High Court of Delhi in W.P (C) 3927 of 2020 filed by Ms. Loganayagi Divya V passed an order dated 22.07.2020 with direction to State of Odisha as quoted below.

"According, we declare that the petitioner stands forthwith relieved from her post in the IPS Cadre of the State of West Bengal. No further orders would be require to be passed by the State of West Benghal in this regard. We direct the State of Odisha to treat this order as a relieving order of the petitioner to enable her to join her post in the IPS Cadre in the State of Odisha".

And Whereas in pursuance of above order Ms. Loganayagi Divya. V has submitted her joining report on 30.07.2020 A.M. before the Director General of Police, Odisha.

Now, therefore in compliance to above orders of Hon'ble High Court of Delhi the joining of Ms. Lognayagi Divya V, IPS in the IPS cadre of Odisha is accepted w.e.f. 30.07.2020 A.M. on her transfer from IPS cadre of West Bengal to Odisha.
