RESOLUTION

NO. HOME-JAIL-RULE-0001-2016/ 31102 -----/ dated the 03/09/16

At present Jail Warders are provided basic training for a period of 09 months.

Whereas difficulties are being experienced by the Jail Officials to manage the security of Jails due to shortage of guarding staff as large number of posts of Warders are lying vacant.

Whereas the vacancy position will increase due to promotion of Warders to next higher rank of guarding staff and also on account of retirement of Warders during the Year, 2016 which may affect the working condition of Jail administration.

Whereas the State Government is vigilant for smooth management of Jail Organisation.

And now after careful consideration of the prevailing situation of Jail and keeping in view the shortage of guarding staff, Government have been pleased to reduce the basic training period of the Jail Warders from 09 (nine) months to 06 (six) months on one time basis with the condensed syllabus in respect of the new batch of warders, 2016 by invoking the provision of Rule-20 of the Odisha Subordinate Jails Service (Method of Recruitment and Conditions of Service of Warder) Rules-2012 which will not form precedence for any other purposes.
