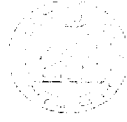



The Selection Committee Meeting held on 29.06.2019 assessed the suitability of Sri Bimbadhar Pradhan (ST) and his name was placed in the select list at Sl. No. 186. Eighteen (18) cases were deferred due to want of inadequate CCRs/PARs. Sri Pradhan, Ex-Desk Officer, Works Department was promoted to the rank of Under Secretary in this Department Notification No. 27321/OSS, dated 12.07.2019 and was posted to Home (LR) Department retrospectively w.e.f. 29.06.2019.

The Review Selection Committee Meeting held on 29.07.2019 assessed the suitability of 15 Desk Officer for promotion to the rank of Under Secretary. In the said select list names of 05 ST Desk Officers were placed from Sl. No.11 to 15. Candidates in the Review Select list at Sl. No.11 to 14 are senior to Sri Bimbadhar Pradhan in the gradation list of Desk Officers. During the Selection Committee Meeting held on 29.06.2019 the case of above 04 Desk Officers was deferred due to want of adequate CCRs/PARs. As a result Sri Bimbadhar Pradhan (ST) was promoted to the rank of Under Secretary on the basis of the said select list dated 29.06.2019.

Since, the 04 senior Desk Officer have been selected in the Review Selection Committee Meeting held on 29.07.2019, Government after careful consideration reverted Sri Bimbadhar Pradhan (ST), Under Secretary to Govt., Home (LR)Department to the post of Desk Officer w.e.f. 29.06.2019. On reversion to the post of Desk Officer Sri Pradhan is allowed to work in Works Department.
