No-HOME-SPS-APMT2-0001-2016- 7821 /SPS, In pursuance of Odisha Police Service (Method of Recruitment and Conditions of Service) Rules, 2013 and General Administration & P.G. Department letter No.GAD-SER2-CSE-0001-2016-3184/SCS dated 01/02/2018, the State Government do hereby appoint the following candidates, who have come out successful in the Odisha Civil Services Examination, 2011 conducted by the Odisha Public Service Commission, Cuttack and now allotted to OPS cadre as per reallocation on the basis of the revised merit list submitted by the OPSC, to Group-A (Junior Branch) of Orissa Police Service in the Pay Matrix corresponding to the pre-revised pay of Rs.15,600 - 39,100/- with Grade Pay of Rs.5400/- in P.B.-3. This appointment shall be subject to fulfilling of the physical standard as laid down by the prescribed regulation issued by Government vide Home Department Notification No.29452/SPS dated 04/07/2011 to regulate the physical examination of candidates for direct recruits. They shall be on probation for a period of 2 (two) years as required under Rule 15 of Odisha Police Service (Method of Recruitment and Conditions of Service) Rules, 2013 and shall undergo training, which includes Institutional Training, Attachment and District Practical Training during the probation period as required under Rule 16 of the said Rules.

These appointments shall be subject to final outcome of the decision of the Hon'ble Odisha Administrative Tribunal in O.A. No.3042(C)/2016 and O.A. No.3043(C)/2016 and related court cases.
